

Defiance ETFs Statement Regarding the Inadvertent Early Listing of the Defiance Autism Impact ETF (ASD)

Miami, June 1, 2026 — Defiance ETFs, LLC ("Defiance") is issuing this notice regarding the Defiance Autism Impact ETF (the "Fund"), ticker ASD.

Due to an administrative error, shares of the Fund became available for trading on Nasdaq earlier today, prior to the Fund's intended commencement of trading. Upon identifying the error, trading in the Fund was halted. At the time of the inadvertent listing, the Fund had not yet been seeded, no creation units had been issued, and no transactions in the Fund's shares occurred.

The Fund's seeding is expected to occur on June 1, 2026, and the Fund is expected to commence trading on June 2, 2026.
